Provider Description:

Alternate learning Styles, Inc. is a locally owned and operated academic clinic based in Fairbanks, Alaska. Our academic clinicians address the needs of students in the areas of reading, writing and math. We serve students in grades K-12. We have delivered Supplemental Educational services (SES) to urban and rural communities across the state since 2002. We offer SES in Fairbanks 45-80 hours over a 5-10 week period, as well as face-to-face services in remote Alaskan communities for a total of 10-12 weeks; this typically works out to 45-60 hours of intensive academic instruction per student if students are willing to attend classes on weekends.

We use the Lindamood Phoneme Sequencing® program and Visualizing and Verbalizing for Language Comprehension® program for decoding, comprehension, and writing, and Best Practices Math for teaching math. 90-95% of our student make gains between three months and three years during their time with us.
