INTRODUCTION

Reading by the end of third grade isn't just a milestone—it's a gateway to success. That's why Alaska has made it a statewide priority as part of Alaska's Education Challenge. Alaska has also signed into law the Alaska Reads Act, which supports and trains PK-3 educators to provide high-quality, evidence-based early literacy instruction. Research over the past decade underscores why this matters. Learning to read is a complex, integrated process that combines decoding and language comprehension to provide access to grade-level content across all subjects.

To support this goal, the Comprehensive Literacy State Development (CLSD) program is authorizing discretionary grants totaling \$50 million over five years to strengthen literacy outcomes for children from birth through grade 12. The program places a special emphasis on students who face the greatest barriers to success, including children living in poverty, English learners, and students with disabilities.

The CLSD grant prioritizes three critical focus areas:

- Leadership Capacity Building – Professional Development and Coaching
- Educator Foundational Skill Building – Professional Development & Coaching
- Family & Community Engagement

The Alaska Department of Education & Early Development (DEED) partnered with Rivet Education to review and vet professional learning providers capable of supporting CLSD grant activities, thereby eliminating uncertainty in selecting high-impact partners with a proven record of improving student outcomes.

Rivet Education evaluated professional learning providers against a rigorous set of criteria, signaling their expertise in high-quality professional learning practices and curriculum-specific knowledge. Rivet-certified providers in this guide are approved to deliver services related to:

- Supporting high-quality early literacy curricula
- Coaching and collaborative planning to support curriculum implementation

Defining Curriculum-Based Professional Learning

Most providers featured in this guide specialize in curriculum-based professional learning (CBPL)—a powerful approach that tightly integrates instructional strategies with the actual materials teachers use in the classroom. By anchoring professional learning in curriculum, CBPL helps educators move beyond theory to actionable, day-to-day practice.

Research conducted by RAND Corporation (2024) confirms the impact: across formats like workshops, coaching, and collaborative learning, teachers were significantly more likely to say their professional learning helped them use instructional materials effectively when that learning was curriculum-based.

CBPL is dynamic, evolving alongside educators. It adapts to different stages of curriculum implementation and levels of teacher and leader expertise, driving sustained improvements in teaching and learning. At its best, CBPL deepens the connection between instruction and content, accelerating student progress and maximizing the return on high-quality instructional materials.

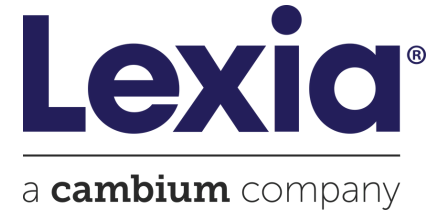
