#### **GRANT PURPOSE**

This program will provide State funded grants through the Department of Education & Early Development to school districts to develop or expand hunter education opportunities for students. Hunter Education programs have been shown to dramatically reduce hunting related firearms accidents – up to 75% in some states – and have brought about positive change in hunter skills, attitudes, and behaviors. Hunters born after January 1, 1986, are required to have completed a hunter education course before hunting in Units 7, 13, 14, 15, and 20 in Alaska. In addition, hunter education certification is required to hunt in specific areas and for youth hunters participating in "Youth Hunts".

These grants will support districts to provide direct hunter education instruction to students and to provide training to individuals to become Hunter Education instructors. Grant activities will occur either during the school year or during the summer prior to June 30, 2025.

Permissible activities include those that—

- 1. Promote the safe handling and use of firearms with students; such as <u>Hunter Education</u> Course, Alaska Department of Fish and Game.
- Provide professional development for teachers or community members to become volunteer Hunter Education instructors under the Alaska Department of Fish and Game Hunter Information and Training (HIT) program <u>Volunteer Instructor Information</u>, <u>Alaska Department of Fish and Game</u>;
- 3. Provide supplies or online course fees necessary for hunter education programs, excluding firearms or ammunition. (Note: The Alaska Department of Fish and Game provides all necessary equipment to complete a hunter education certification course.)
- 4. Cover firearms safety, wildlife conservation, and respect for natural resources, landowners, and other hunters.

#### **GENERAL INFORMATION**

#### **Funds:**

DEED expects to make between ten and twenty (10-20) awards until available funds (of at least \$500,000) are expended. Awards may range from \$20,000 to \$50,000. Unfunded applications will be ranked in order of scoring and may be awarded as additional funds come available.

Grant funds will be distributed as an up-front block grant to support activities from February 1, 2025, through June 30, 2025. Grant funds should be spent by June 30, 2025. Grantees will submit a final narrative report at the end of the grant period clarifying how grant funds were expended and the number of students served.

#### Design/Intent:

The expectation for grant recipients is that these resources will strengthen hunter education programs for students. and will be directly serving students during the 2024-2025 school year and beyond.

#### Cover Page:

- actions/purchases that this proposal will fund to provide hunter education
- any external funds or resources to be leveraged for the advancement of the proposal
- a clear statement of whether your proposal will use Alaska Department of Fish & Game programs or materials.

#### Timeline/Sustainability Plan (35 points)

Provide a concise (no more than one page) narrative that includes:

- a timeline of implementation addressing the five-month implementation period
- clarification of those responsible for timely implementation

 how capacity will be enhanced to sustainably serve students during the 2025-2026 school year and beyond

#### Budget - Standard DEED Budget/Narrative Form (25 points)

Submit a proposed budget broken out by expense type and accompanying narrative using the standard DEED <u>Budget/Narrative Form #05-07-071</u> completing both the budget and narrative pages.

#### Additional Points (up to 20 bonus points)

In addition to the 100 points possible for each application noted above, 10 bonus points will be awarded for applications from grantees serving rural school districts and 10 additional points for districts utilizing existing Department of Fish and Game Hunter Education resources and training for instructors.

AS.14.43.700 "Rural" means a community with a population of 7,500 or less that is not connected by road or rail to Anchorage or Fairbanks or with a population of 1,500 or less that is connected by road or rail to Anchorage or Fairbanks.

#### APPLICATION REVIEW and SCORING

Applications containing the four required parts noted above and received by the 5:00pm January 17, 2025 deadline will be scored and ranked according to the quality of responses and proposed actions by the DEED grant review team. Final application scores will be used to rank applications in order of eligibility of funding. Grant awards will be made according to this eligibility list until available funds are expended.

#### **Program Administration**

Submittal of an application will show the applicant's acceptance of all the terms and conditions contained in this Request for Applications. The contents of the application will become contractually binding if a grant is awarded. Failure of the successful applicant to accept these obligations may result in cancellation of the award. All submittals become the property of the Alaska Department of Education & Early Development and are open to public inspection at all reasonable times after they are reviewed.

#### **Appeals Process**

Formal protests will be handled according to Chapter 40, Alaska Administrative Code, Appeals of Decisions to Deny or Withhold Funding 4 AAC 40.010. This information is available online (https://www.akleg.gov/basis/aac.asp#4.40.010).

#### **Fiscal Procedures**

Eligible expenditures ordinarily will be limited to those directly necessary and reasonable for proper and efficient performance and administration of the proposed grant activity. These customarily might include personnel salaries, benefits, consultant fees, materials and equipment, travel, administrative supplies, etc. Indirect expenses may be charged to the grant provided the applicant has an approved indirect cost rate according to Federal guidelines and will be capped at 5%. The eligibility of any disputed item shall be determined by the Department of Education & Early Development, and the sponsoring institution or agency shall be responsible for any disputed expenditure. Changes in budgets after issuance of grant awards must receive written approval from the Department prior to implementation.

Grant recipients are responsible for ensuring that audit and accounting procedures are in compliance with the appropriate state requirements.

#### Cancellation

The Department of Education & Early Development reserves the right to cancel any grant awarded through this RFA for any of the following reasons:

- 1. If the grantee demonstrates fiscal irresponsibility;
- 2. If the grantee fails to perform in accordance with the conditions of this RFA;
- 3. If the grantee fails to perform in accordance with the application proposal and any negotiated modifications; or
- 4. If the State no longer has funds available for the project resulting from this RFA.
