As a mother of a 13-year old daughter in the Matsu School District, I support the proposed school board regulation changes. Thank you for proposing to protect our girls - their privacy, their achievements, and their identity. our girls have a right to maintain women's sports and a fair chance to succeed. It is difficult enough being a kid and competing against other girls.

I remember middle school as the most difficult time in my childhood and high school being the next. I would assume if this proposed protection for girls did not pass it would open doors for accepting boys in all avenues of girls sports including the locker rooms. In middle school I did not even want to undress in the locker room and shower with other girls, but I had to in order to get a good grade in P.E. I cannot imagine having to undress in front of a boy. To require that would feel like sexual abuse and could be psychologically and emotionally damaging. To normalize this would also put girls at risk for actual physical sexual abuse and decreased reporting because of the culture of society not valuing their privacy and safety.

Middle school and high school sports are challenging enough competing against other girls. I remember coaches giving favoritism to certain girls and those girls would end up being the ones to bully me. Other than those challenges though, I enjoyed sports and having a chance to succeed. I can't even imagine how allowing boys in girl's would change that dynamic. Not getting to be the position you hoped for because a male performed better. Trans activists attempt to say it does no harm to girls, but that is just not true. There are many cases of girls who normally would have been top performers and received scholarships for their achievements. Women are tired of working their butts off to be the best and not winning because a biological male beat them. I don't even need to state any examples. They are easy to look up on the internet.

I just want to show my support for this proposal. My number one priority is the safety of our girls.



Deputy Commissioner Heidi Teshner:

Thank you for having a public comment and testimony period to hear the concerns and feedback of your Alaska community. <u>I write to you in **strong opposition** for the proposed regulation changes to 4 AAC 06 of the Alaska Administrative Code regarding transgender girls playing in sports.</u> There were 38 testimonies in opposition during the Alaska School Activities Association (ASAA) testimony period earlier this year, and I hope you reject this similar language as they did. Below elaborates why I feel strongly that these regulations would be harmful to our youth, all statistics are from the <u>The Trevor Project: 2023 U.S. National Survey on the Mental Health of LGBTQ</u> <u>Young People</u>.

- According to the <u>National Federation of State High School Associations</u>, which ASAA is a member of, students participating in education-based sports enriches their educational experience, promotes academic achievement, and encourages positive community and school culture. These opportunities should be afforded to all of Alaska's youth.
- **Trans girls are girls.** Assuming anything else is discrimination and not a call that others get to make about someone's identity. The notion that "they can play but on a different team" is exclusionary and invalidating to who they are. In the words of an opposing testifier during the ASAA testimony "People are not remembered for those they exclude."
- We should be fostering protective factors to keep the physical and mental health states of our kids at its best, not stunting their availability of opportunities to learn and grow. Roughly half of transgender and nonbinary young people found their school to be gender-affirming, and those who did reported lower rates of attempting suicide.
- <u>Perthe CDC</u>, Alaska has one of the worst suicide rates in the country. 48% of trans girls reported seriously considered suicide in the past year and 16% attempted suicide. These regulations would compound a disparity we already face within the LGBTQ+ community and state.

- Our governing bodies should be sending messages that our kids belong in public school activities. Nearly 1 in 3 LGBTQ young people said their mental health was poor most of the time or always due to anti-LGBTQ policies and legislation.
- Playing sports in school should be a safe place for Alaska youth irrespective of their diverse backgrounds and experiences. The melting pot of diversity that Alaska is makes us a more beautiful and vibrant community! Fewer than 40% of LGBTQ young people found their home to be LGBTQ-affirming.
- Passing this regulation would invite gender policing, calls for unnecessary investigation, and make our youth vulnerable to bullying and being subject to rumors. 27% of transgender and nonbinary young people reported that they have been physically threatened or harmed in the past year due to their gender identity.
- These proposed regulations raise serious privacy concerns. They could "out" our transgender youth by not allowing them to play on the team that aligns with their gender identity and potentially make them subject to invasive physical examinations outside routine for participation in interscholastic sports.

The proposed changes to 4 AAC 06.115(b)(5) are unnecessary and would likely result in harmful outcomes to an already marginalized subset of Alaskan youth. The proposed rule change appears to be based on ideology from the conservative right rather than a need to address an actual problem. I have seen no information provided by supporters of the changes that demonstrates a real need for such a rule. Transgender youth already face significant emotional stress, bullying and an exceptionally high rate of suicide. School sports are an important component of youth development and provide opportunities to create friendships, promote good health, develop team building skills and so much more. Singling out a small group of vulnerable youth that already face extremely challenging emotional and social issues and subjecting them to additional prohibitions and public / social scrutiny runs counter to the goals of public education. The education system should be focused on helping youth develop into informed, high functioning members of society that are able to work together for the betterment of themselves and communities at large. The proposed rule change would further alienate and subjugate a group of at-risk youth in Alaska, while providing no meaningful benefit to the education system. Members of the State Board of Education & Early Development:

First of all, thank you for your willingness to volunteer on behalf of Alaska's students. It takes time, and board service is often thankless work, so I want to express my appreciation. Additionally, I am pleased to see the board meeting outside of Juneau, Anchorage, or Sitka. It would be wonderful to convene the board in even more remote communities, to allow more Alaskans the opportunity to provide input and meet board members in person.

A critical foundation of our democracy is public input. Whether the input is through testimony on a topic, or through a ballot box, our system is informed by the people it serves and, as such, our system very much relies on sound public process. Thank you for taking my testimony.

On the July agenda item addressing "proposed changes on interscholastic activities," I would like to offer this testimony.

In a review of the steps that have led to your consideration of new regulations that would apply to every student in Alaska, I would like to remind you of the following timeline.

In the 32nd Legislature, SB 140 failed to pass in both legislative years. In the current, 33rd legislature, HB 27 failed to receive a hearing. Both of these bills contain language similar to the language of the State Board's resolution 02-2023.

As a reminder, the State Board passed Resolution 02-2023 at the March meeting. To be absolutely clear, this item was added to the agenda the morning it was considered, with no prior notification to the public, effectively preventing interested parties from providing their input on this important topic. While this may fall within the bylaws of the State Board, it does not reflect good public process.

In a meeting in my office the day after the resolution was passed, Chair Fields responded to my concerns about this process by telling me resolutions are "non-binding," and the item had been added at the request of a board member at the last minute. Again, I question the board's commitment to sound public process in considering and then passing this resolution.

So, to arrive at the current moment, our State Board ignored the failure over three years of legislative attempts to pass legislation through a rigorous committee and public input process when a resolution was added to the board's agenda at the last minute in March, preventing public input. As a result of this "non-binding" resolution, the Alaska Student Activities Association considered a change to their by-laws in the following months, and the Department of Education and Early Development has proposed regulations for consideration and adoption. These organizations clearly interpret "non-binding" differently than Chair Fields.

This leads to the heart of the matter: what is driving the board to seek these changes? The purpose of public process is to solve the problems of our state and our communities in a way that elevates Alaskans and improves our quality of life. Most locally elected school boards have already created policies regarding the issues the State Board's resolution seeks to address, and, moreover, there is no clear sense of a need to address these issues in the first place. I challenge the board to produce even one example of harm caused by transgender athletes in Alaska.

I would like to remind you all that many states elect their state boards, others have both appointed and elected seats. Alaska's board is solely appointed – none of you has endured the public scrutiny of earning your seat through an election. The board has made great strides in areas important to the state through your continued commitment to Alaska's Education Challenge. Creating the Education Challenge involved input from hundreds of Alaskans over hundreds of hours and is therefore representative of the will of the people, and I commend you for your steadfast commitment to the goals of the Challenge.

Again, thank you for serving, and I look forward to the board returning focus to the very real needs of our schools and students.

I am writing to oppose the ban on transgender girls patticipating in girls' sports teams. For one thing, we do not have widespread examples of transgender girls outcompeting cisgender girls in high school sports. For those who say that we are being proactive, I would say that transgender girls have been around for years. Gender affirming care has been around for years. If transgender girls competing in sports was an actual issue, we would have many examples of transgender girls outcompeting cisgender girls by now. Instead of this ban being proposed because of an issue facing girls competing in Alaskan sports, this ban has been proposed based on prejudice and fear mongering.

Second, this ban is being proposed with seemingly no plan for how to actually implement it. How does the DEED propose that sports teams will verify if girls are cis or transgender? Does the DEED plan to punish students or coaching staff who violate this ban? For transgender girls who recieved gender affirming care at a young age, no one would know that they were ever transgender by the time they reach high school. Because of this, verifying that transgender girls are not competing in girls sports would require verifying that every girl on a girl's sports team was assigned female at birth. This would likely require verifying the birth certificates or medical records of all female athletes, leading to more beaurocracy on the part of coaches and sports team administrators, which is the last thing they need. Even if the DEED deemed that all this is necessary, transgender girls and their parents could simply refuse to sign off on giving access to their medical records and birth certificates. In this way, unless schools want to ban girls who don't give access to their most private medical records from competing in sports, there is no way to ensure that no transgender girls are competing on girls sports teams.

Lastly, when I was in high school, I participated in girls' sports as a cisgender girl. I would have had no problem competing against transgender girls, especially if it meant that they would feel less stigmatized. For me, competing in high school sports was more about participating than winning. I think many high school athletes, except the most elite, share this sentiment. I would bet that if you asked most high school girls in Alaska, they would have no problem competing against transgender girls.

Dear Chair Fields and Members of the Board of Education and Early Development,

I write in support of the proposed amendments to regulations ensuring the fairness, safety, and equal opportunity for biological female students participating in interscholastic activities. School sports have been an enriching activity for countless Alaskans that promote student health and wellbeing. They are a vital part of Alaskan students' educational experience, and I hope that our competitive sports continue to be a valuable part of the school experience for Alaskans for generations to come.

First, I must acknowledge the difficulty of the decision before you. Board of Education decisions are primarily based on objective facts and data. Yet the purpose of regulations on interscholastic activities is to "provide a procedure that enables school districts to promote and govern interscholastic activities effectively, economically, and *fairly*, while keeping those activities in their proper perspective educationally" (*4 AAC 06.115 (a)*, emphasis added).

Reasonable people can agree or disagree if a situation is fair or not. Presently, this is the position in which our society has found itself as it relates to transgender athletes in women's sports. However, the scope of the proposed regulations before you consider *competitive fairness*. Fortunately, in this area there is considerably more clarity.

Sports in Alaska have been organized for competitiveness. This is evidenced in the classifications and divisions in the regional organization that exists within the Alaska School Activities Association. Competitive sports in Alaska have various categories of competition with appropriate classification criteria. In sports like football and basketball, schools are placed in different divisions based on the size of the school population. In the case of wrestling, the athlete's weight is used to further clarify fair competition. Additionally, Title IX provides guidance for the establishment of different teams for boys and girls to provide more students the opportunity to compete fairly. Competitive sports classifications have effectively ensured fair competition among Alaskan student athletes for decades.

Furthermore, when sports classifications are competitively fair, they are also safer, particularly in contact sports. While all activities carry some risk, the risk of injury in sports is increased when

an athlete is matched up with an opponent who is considerably larger, stronger, or faster. Every competition features some differences in the physical abilities of the competitors and the rules of every sport minimize the risk of injury. However, the changes that occur during puberty amplify the physical differences between male and female. Genetics cannot be changed. Because of this, transgender athletes in girls' sports are significantly more likely to create physical disparities that increase the risk of injury to the smaller athlete.

Paramount to Title IX, the Biden administration has proposed changes to Title IX regulations regarding student eligibility for athletic teams. The State Board's proposed regulation supports Title IX's nondiscrimination requirement as it focuses on high school sports. In line with the Biden administration, the State Board recognizes that for older students, including high school children, sex-related criteria can be used to determine participation eligibility if the criteria enable the school to achieve fairness in competition as it is an important educational objective. I applaud the careful consideration the Board has taken in your proposed regulations as they are in concert with both the letter and the spirit of the law.

It is important that the State Board adopt such regulations to ensure that the boundaries of fair competition are applied consistently across the Alaska. Strong local control in education ensures that Alaskan communities have the most influence over how their schools operate. Nevertheless, interscholastic activities are not confined within one school district. 4 AAC 06.115 describes the authority the Alaska School Activities Association has in establishing common rules and regulations for school activities within parameters set by the Department of Education and Early Development. The proposed regulation is a necessary and appropriate parameter to ensure fairness, safety, and equal opportunity for female athletes.

As you may know, some media coverage of the proposed regulation has mischaracterized it as prohibiting transgender students from sports. It is unfortunate that the regulations you have proposed have been misrepresented. I appreciate that the State Board seeks to clarify the classifications for which a high school student is eligible to compete, and that no transgender student in Alaska will be or should be prohibited from participating in school athletics due to this regulation.

In closing, one suggestion that I have is in replacing the language "females who were assigned female at birth" with "biological females." This change would better align the regulation's language with the K-12 Science Standards for Alaska.

Thank you for taking such an important step for Alaska's students in approving regulations that ensure the fairness, safety, and equal opportunity for all students, including biological female students, participating in interscholastic competitive sports.

Participation and support for female supports is based on the range of abilities possessed by humans born without a Y chromosome. The development of a female human's physical attributes differs from those born with a Y chromosome in muscle strength and geometry of bone structure. Sporting activities should be separated in most sports by sex at birth and not a person's self perception of something they are not. Females should not be forced to share locker rooms, bathrooms, and other changing rooms with males masquerading as females. Male and female genders are recognized at birth with very few physical exceptions. Gender is determined by observation and not self-identification.



I write to voice my opposition to the Board's proposed amendment to exclude transgender girls from participating in girls' sports at school. I am a 26-year Alaska resident, and have two children that attended public school in Anchorage and participated in sports. I was a three sport athlete in high school, including swimming and track. I firmly believe that the proposed amendment is harmful to transgender students and does nothing to meet the purported goals of equity and safety. Cis-gender students may also be harmed by this because they might have to "prove up" their gender. The proposed rule does nothing more than carry into our schools the "them v. us" fear that is driving our political and social lives in this country. Leaders in our community purport to want to bring people together, support all students' achievement and diminish the divisiveness that exists in our country. This amendment is in direct contradiction to those goals. There was a quote from the upcoming student board member in the newspaper recently, and his comment relays my thoughts on this topic better than I can express on my own. Felix Myers, the rising senior from Sitka who begins his tenure as the yearlong student representative on the board next month stated the following:

"We have not seen this be an issue in Alaska," Myers said. "And there's a reason for that. If you have talked to trans students, if you know these kids, they are in fear of competing in athletics, because of the vitriol, because of the harassment, because of what they face if they are put into that situation. And everyone knows — they face it from adults, they face it from their peers, they face it from their competitors."

Myers told fellow board members it was "an embarrassment" for an unelected board to take action on a politically divisive issue, rather than leaving it to the Legislature.

"This is just delegitimizing what incredible work this board is capable of doing," said Myers. "For us to delegitimize all of that work by focusing on a tiny culture war issue that is not a real issue, but does in fact hurt and delegitimize what the students of this state are going through being trans in a country that does not love them — is below us."

I hope the Board reconsiders its decision and votes down the proposed amendment.

As a parent and a former military advisory member of the State Board of Education, I unequivocally support the proposal to ban biological males from competing against females in high school sports. I have three daughters and three sons and a wife who played collegiate soccer. I have personally witnessed the undeniable physical advantage biological males possess over biological females. Men are, as a group, just naturally stronger and faster than women and therefore hold an unfair advantage when competing against them in athletics. This is not a "sexist" position (my wife and three daughters will tell you the same thing), it is simply a matter of biology. My entire family has, at various times, competed in a variety of "co-ed" sports (soccer, softball, volleyball, flag football, etc.) and each one of them will tell you that while there are some female athletes who can compete head-tohead with males, they are by far the exception to the rule. This in no way diminishes the athleticism or achievements of female athletes, it is, as I said before, simply a matter of biology. Males are built differently than females with, generally speaking, more muscle mass and overall size. It is GROSSLY Unfair to allow biological males to compete with females. Regardless of any "measures" or "procedures" which a male has undergone to feminize his appearance or physique, or how he may profess to "identify" his gender, his DNA and at least the vast majority of his biological underpinnings are still male. 



My name is Mae Marsh and I am a resident of Fairbanks, Alaska. I am a retired Equal Opportunity Director, Title IX Officer, Title IX Coordinator, and Title IX Investigator.

I am writing to support this amendment and include a recommendation.

The rationale buttressing my support is as follows:

- Equality for women in sports is guaranteed under Title IX.
- Title IX is based on sex.
- Sex is biological. Sex is not a decision made by doctors at birth. Sex is not a social construct, it is not fluid, and it is not on a continuum.
- Sex is binary there are only two sexes male and female. Hermaphrodites or intersex individuals consist of 0.018% of all humans.
- The two sexes compete in separate competitive or contact sports because there are biological differences in size and strength which could result in physical harm.
- Gender refers to one's internal sense of being and is a social identity.

• Gender is fluid and currently refers to 72 separate social identities. • Biological males who transition use hormones and/or surgery in an attempt to alter their social presentation to reflect their internal sense.

• Language is important and conflating the terms 'sex' and 'gender' creates confusion in the application of the law.

• Additionally, incorporating the concept that sex is assigned at birth blurs the lines because that is a concept that is related to gender.

• Allowing biological males who chemically and/or surgically transition to a different 'gender' to compete in female sports robs females of opportunities for college scholarships, corporate sponsorships, and status.

• Allowing biological males who chemically and/or surgically transition to a different 'gender' to compete in female sports violates the intent of Title IX, which is to ensure equality in sports based on sex.

While I'm using a form to submit my comments, please know that my beliefs on this issue are personal.

I oppose the proposed regulation changes to 4 AAC 06 dealing with school sports. I believe trans girls should have the opportunity to play on sports teams that align with their gender identity.

I'm concerned that the Dept of Education is tackling a hot button issue that has not raised concerns on the local level. Parents aren't asking for this change. Students are asking for this change. School Districts have had no part in requesting a rule change.

In fact, I think you would find that most school districts far prefer retaining the local control that exists today. Each district has the power and authority to clarify their own rules about who is qualified to play on their sports teams.

Local districts are best suited to make these decisions because they know their students, and are set up to solicit and respond to local input.

For instance, several years ago in Haines, a transgender student wanted to participate on sports teams. She had been living as a girl for several years, but was new to the district. School administrators were able to confirm her gender identify confidentially, and work to ensure that her privacy was protected. Isolated concerns about locker room protocols from some families were calmly discussed and accommodations were made for alternate changing areas when needed.

The Haines athlete participated on multiple sports teams while she was in high school, and recently returned to town to attend a family event. She remembers the respectful, supportive environment that Haines officials created.

I do not know of a single instance in Alaska when a trans girl spoiled another athlete's chances of getting into college or competing at a higher level after high school. I do know that up until now Alaska's core principles of privacy, independence and personal autonomy have served us well. Let's keep it up. We don't have to follow the herd of anti-trans activism. Let's stick with our values, and support all students in their desire to be successful, healthy and happy.

I'm writing to express opposition to the proposed changes to interscholastic activities that would restrict the ability of transgender girls to participate in sports. I believe the intent behind it is discriminatory and that it would fail to advance fairness, safety, and equal opportunity for students.

As far as I'm aware there is only a single student that is being targeted by this legislation and it is my understanding that they are not dominating their sport. This is consistent with the finding throughout the world that transgender women compete at a comparable level to women assigned female at birth. There is clearly not a need for this change but it coincides with increasing partisan anti-transgender fear and bias.

I'm assuming the thought behind the legislation is that individuals assigned male at birth have higher testosterone and bone density then those assigned female and that they therefor pose a threat and have an advantage of their peers. If this is the intent then the regulation fails to address that concern. Note that many athletic organizations have been able to have transgender women participate in sports and that these concerns are often unfounded.

It is laughable that a handful (or a single student in this case) poses any meaningful threat to women's sports.

The primary reasons that I hear people supporting this regulation change are bigoted and discriminatory. The data clearly shows that transgender women do not have an unfair advantage over cisgender women. Transgender people represent about 1% of the population, meaning about 1% of women are transgender, so - if all things really are equal - we would expect 1% of the victors in women's sports to be transgender women. That's not what we see. If transgender women had an unfair advantage, then we would expect to see more than 1% of women's trophies going to transgender women. That's not what we see. What we actually see is that far far less than 1% of victors are transgender. Until more than 1% of those women's trophies are being won by transgender women, this isn't about making sports fair, it's about dehumanizing transgender people, which is step one of the white supremacist's playbook.

As more concrete examples, consider Lia Thomas or Glenique Frank. Glenique Frank is a transgender woman that ran in the London Marathon. Conservatives like to bring up that she beat 14,000 women; what they choose to omit is the fact that she placed 6,159th, placing her well in the middle for someone with decades of running experience. Lia Thomas is a professional swimmer. Prior to transitioning, she was 10 seconds behind the men's world record for her particular event; after transitioning, she is now 10 seconds behind the women's world record. That seems like exactly what we would expect if this was fair.

These attacks on trans youth are nothing more than white supremacy. That's the only logical conclusion I can draw because that's what the data indicates - because that's exactly where the nazis started. Adolf Hitler once called Dr. Magnus Hirshfeld "the world's most dangerous Jew." Do you know why? Because he studied transgender people with compassion. That was it. That was all it took to make him the most dangerous person as far as the nazi riech was concerned; treating transgender people with compassion.

Which is pretty stupid considering how long transgender people have existed. Transgender and non-binary people predate the christian religion. They're talked about in ancient Sumerian culture, ancient Babylonian, ancient Mesopotamian, ancient Indian, ancient Japanese, in ancient maori, ancient aboriginal, native hawaiian, native american, and native alaskan cultures, again all of which predate christianity.

Causing harm to transgender people - which is exactly what this ban would do - is just the next step in the white supremacist playbook.

If it's the goal of the Alaskan Education system to push white supremacists ideals, then support this regulation.

If y'all want to push ideals like equality, freedom of choice, and personal liberty - you know, supposedly American ideals - then please stop this hate based regulation.

I have competed in sports all my years of middle school and High school. Forcing girls to compete against boys in sports is not fair. Boys are physically different and are not the same as girls. When males compete against females, males have an advantage. Males tend to be stronger, faster, and more athletic. One example of the difference between the performance of a male versus female is this past years division 1 cross Country state championship. The winner in the boys division ran a 16:13, the winner in the girls division ran a 19:16. That is a 3 minute difference in the 5k time of a male vs female High school athlete. I am writing to express my **full support of the proposal as written to prohibit transgender malesto-females from participating in K-12 girls' sports activities**. In fact, it is my expectation as an Alaska resident, parent, and registered voter that the Board **MUST** enact this proposal. I am a registered nurse and have worked in the neonatal/maternal-child/pediatric realm for over 30 years, currently focusing on child and adult injury prevention programming.

I am a graduate of the Anchorage School District (grades K-12) and completed my post-secondary education in Alaska. My three children are graduates of the Anchorage School District, as well. My children and I all participated in school competitive athletics, having earned several varsity letters during our high school years.

Allowing biological males, who by their undeniable genetic makeup have the potential for larger bodies, increased muscle mass, and superior physical performance, would place biological female athletes at increased risk for injury. Additionally, those injuries could lead to permanent impairment and morbidity. Even in "non-contact" sports, such as volleyball, a biological male athlete would have the potential to spike the ball at much higher rate of velocity and force than typical for female athletes into the head of a biological female athlete, causing permanent traumatic brain injury. Allowing even the possibility of such scenarios to exist is unacceptable.

Alaska's own Olympic champion, Lydia Jacoby, may have never risen to the top swim racing levels of her sport had she been competing against biological males. Title IV is far too important and was a hard-won victory for female athletes to allow it to be buried by nonsensical social pressure being exerted by a minority of citizens. My name is Shelly Soderstrom and it has been brought to my attention that the State Board of Education will be voting on weather or not to allow Transgender Athletes compete against Biological Gender Athletes. I would like to take the time and let you know why I feel we need to keep girls sports only to biologically born females.

I have a daughter that is a cross country skier and just finished her first year of high school this last spring. When she was 5 years old she came to Me in the kitchen and told me she wanted to go to the Olympics as a Nordic Skier. According to the UCLA Williams Institute, 0.6% of the population are transgender in the United States. Additionally, I feel it is necessary to mention this concerning statistic: according to the National Library of Medicine, 82% of transgender individuals have considered killing themselves, and 40% have attempted suicide (with rates the highest for transgender teens). I oppose the proposed regulation changes to 4 AAC 06 dealing with school sports.

As the mother of a transgender girl, these public legislative and policy attacks feel deeply personal and make me fearful for my child's safety. My kid is not a threat. The amount of time our family has spent this year, standing up for our transgender child's basic human rights, is substantial. It is exhausting. And it is so, so damaging for our child to hear these persistent attacks on them by people in elected or appointed positions of leadership.

Transgender students who want to play – children who just want to play – are not a threat. They do no harm by their existence in this world or participation in school sports. These actions serve to weaponize sports to bully and dehumanize transgender children.

There is no evidence to support that transgender athletes are impacting girls' sports negatively. In fact, the opposite: according to a report from the Center for American Progress, when a state has a policy that includes transgender athletes, participation for cisgender women and girls is stronger. Further, banning trans women and girls from sport also puts cisgender women and girls at risk because anyone who falls outside of what is deemed stereotypical feminine may be forced to "prove" she is a woman or girl, which leads to invasive screenings and procedures to verify gender.

We are not talking about high-stake competitive sports here – we are talking about kids, and the goal should be encouraging participation. Dr. Karissa Niehoff, National Federation of State High School Associations chief executive officer, stated in May 2022 "What is the purpose of high school sports? It's the health and safety of participants, as well as developing life skills and citizenship. Is it to win? No. Is it to offer an opportunity? Yes." If any of our kids have the combination of talent, determination and dedication to move into collegiate, professional or Olympic level sports, there are existing policies in place at each of these levels to encourage fair and inclusive participation of all athletes.

The proposed bylaw changes will perpetuate government overreach and surveillance and will single out a vulnerable group of youth who already face extreme bullying and harassment simply for existing, and especially when participating in the sports they love. Actions like this make school less safe for transgender kids and will increase harassment and body policing for all girls.

Sport spaces help children develop critical life skills like communication, teamwork, and leadership — and give them a community of peers with whom they connect and can develop life-long friendships. These spaces are imperative for all kids, no matter their gender. We should be finding ways to create more opportunities for kids to be active and engaged with their peers, not denying them access.

He openly told me how he got away with keeping his john from discovering he was a biological male during sex. He had 5 pimps to protect him and they got a monetary cut of Archie's trade. This is not something I'd recommend investigating too deeply; it will make you sick. But Police Officers deal with this scum daily, out of necessity. Thank God for good cops who hold to their oath of office.

The majority of street prostitutes have pimps. When I and the 2 officers on our beat assigned to the other shifts got the prostitutes to leave our beat (took 3 months and it was done legally), naturally pimps went with them and instantly, our human trafficking kidnaps, rapes, and murders ceased.

Realistically, any male who "identifies" as a female is displaying a sexual perversion. Truly not all transgenders are violent. But when they invade women-only functions, they're preying on women.

We can prevent this by making it illegal for biological males to prey on females. Just say no, lawfully. And make it tough; put teeth into it.
