



Alaska Reads Act Year 1 Evaluation Findings



The Alaska Department of Education and Early Development (DEED) seeks to address the education challenges in Alaska by utilizing DEED’s strategic plan which has identified five positive trajectories, with the first being to “Support ALL students to read at grade level by the end of third grade.” **The Alaska Reads Act was signed into law in June 2022 and led to the creation of four new programs:**

- 1) District Reading Improvement Plan
- 2) Department Reading Program
- 3) Virtual Learning Consortium
- 4) Early Education Programs

DEED began its partnership with Pacific Research and Evaluation (PRE) in September 2024 to conduct a third-party evaluation of the AK Reads Act.

- Student literacy outcome data from the 2023-24 school year will be used as baseline data in future study years to demonstrate the impact of the AK Reads Act over time.


...reported that their reading intervention program aligned with their core curriculum.




Among the K-3 students who scored below or well below proficient on the DIBELS literacy screener in the fall of 2023...




Kindergarten


