Notice of Public Scoping Under Administrative Order 360 for possible Department of Education and Early Development (DEED) Regulation Changes Title 4. Education and Early Development [All-Inclusive].

On August 4, 2025, Governor Mike Dunleavy issued Administrative Order 360 to improve the quality, transparency, and efficiency of Alaska's regulatory environment by requiring a 15 percent reduction in regulations by 2026 and 25 percent by 2027. In response, the Alaska State Department of Education and Early Development will hold a series of special virtual meetings starting on Tuesday, October 02, 2025, and running through Thursday, December 18, 2025. Public participation in the meeting will be conducted through the digital platform Zoom. The public is invited to attend this meeting by joining online through Zoom or via phone. **Background.** In response to Administrative Order 360, the Department of Education and Early Development is soliciting written and oral comments from affected industries, community organizations, and the general public regarding regulations and materials incorporated by reference in Title 4. Education and Early Development, Chapter 03. Through Chapter 67 and Title 40. Public Records and Recorders, Chapter 21, pages 75-97.

DEED is undertaking this solicitation process to ask the public for ideas, suggestions, and input before DEED drafts or proposes any specific regulation amendments or repeals for public review.

The Department of Education and Early Development is particularly interested in specific ideas for regulatory change that may:

- Clarify existing regulatory obligations;
- Reduce costs for the public, industry, or government;
- Improve or streamline procedures, application requirements, and review processes, for example reducing the time required to apply for a license, permit, or benefit;
- Reduce administrative burdens;
- Streamline permitting procedures;
- Improve communication procedures;
- Provide greater transparency with respect to standards, decision-making, and rationales for application processing; or
- Clarify interagency roles.
