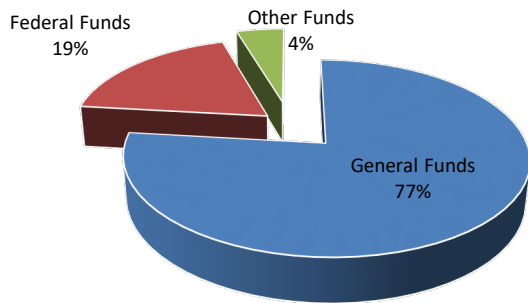

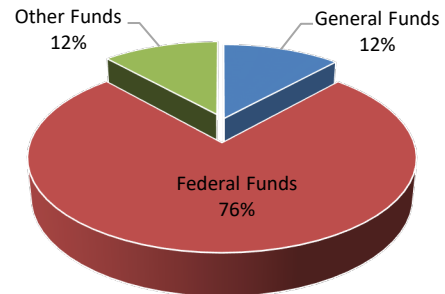

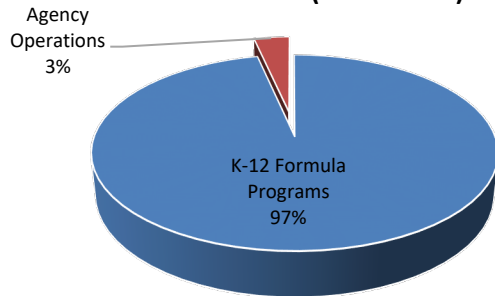
FY2020 Operating Budget by Fund Source



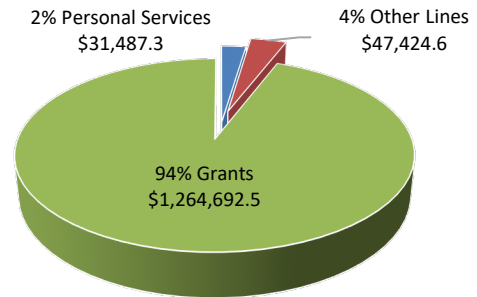
FY2020 Agency and Program Operations by Fund Source



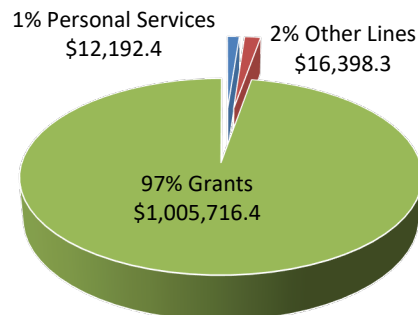
FY2020 Operating Budget General Fund (UGF & DGF)
