

# STRONG POLICY MAKES A DIFFERENCE IN EARLY LITERACY



The Alaska Reads Act, signed into law in 2022 by Governor Mike Dunleavy and co-sponsored by former Senator Tom Begich, is designed to ensure all students can read at grade level by the end of third grade. This landmark legislation seeks to transform early literacy education by incorporating systematic, evidence-based instructional practices rooted in the Science of Reading and rigorous educational and professional teaching standards.

## LITERACY FAST FACTS

#### MAJOR FEDERAL INVESTMENT IN LITERACY

Alaska was awarded \$50 million in 2024 through the Comprehensive Literacy State Development (CLSD) grant to strengthen literacy from birth through Grade 12

#### **CLSD GRANT AWARDS**

26 Alaskan districts applied for the CLSD grant, each articulating plans to improve literacy from birth through grade 12, and all will receive funding to implement evidence-based strategies aligned with the AK Reads Act

#### **ALASKA EDUCATORS ENDORSED**

As of June 2025, 2,932 educators hold an official Alaska Reads Act endorsement—including teachers, administrators, and early education

#### **SCIENCE OF READING SYMPOSIUM ROCKS!**

Over 4,000 educators have participated in Alaska's Science of Reading Symposium since its launch— connecting research with Alaska's classrooms

#### **VIRTUAL LEARNING IS THRIVING**

The Alaska Virtual Learning Consortium supported 2,400 course completions, awarding 861 Continuing Education Units (CEU) to educators across the state

#### **DEPARTMENT READING PROGRAM**

50 schools across 7 districts will participate in the 2025-26 Department Reading Program, which provides intensive reading support to the lowest 25% of schools through coaching and school-wide improvement plans

Utilizing standardized tools to assess early reading skills

Implementing evidence-based reading instruction methods

Providing rigorous professional development for educators to deepen their understanding of effective reading instruction



#### **Individual Reading Plans**

Developing tailored educational strategies to meet the unique needs of each student



#### **Intensive Tutoring & Summer School Options**

Offering additional support and learning opportunities to ensure students meet literacy benchmarks

Engaging parents in their children's educational progress to foster a supportive learning environment




# AK GRADE LEVEL SKILL ACHIEVEMENT




# GROWTH IN STUDENT LEARNING
