

Alaska Reads #akreads

House Bill 114, Chapter 40, SLA 2022 Passed May, 2022

Alaska Early Education Program Standards

A framework for early education programs operated by school districts. Effective July 1, 2023

EEP Grant Program

Provides resources to districts that are working to implement the EEP Standards.

Began 2023-2024 school year

0.5 ADM Funding

Allocated for programs that meet the EEP Standards.

Began 2023-2024 school year





Origin:

The Alaska EEP Standards were prepared in response to statute passed May 2022. Alaska Reads Act AS 14.07.165(a)(5)(A)

- Developed by a team of stakeholders across the course of a year
- Meet statutory and regulatory requirements
- Incorporate requirements unique to Alaska's needs

Took affect July 1, 2023 after being adopted by State Board of Education.

(A) standards for a locally designed, evidence-based program that meets Head Start Program Performance Standards and other federal standards required for early education programs to receive federal funding;



Purpose:

- Provide a framework for district preschool programs.
- Provide criteria for DEED to approve districts to count 4- and 5- years old preschool students in the OASIS count for formula funding.



Early Education Program Standards are currently being revised

Legislative mandate passed June 2024:

- House Bill 148 removed a line from AS 14.07.165(a)(5)(A)
- The language to "meet Head Start Program Performance Standards" was removed.

- Purpose:
 - Develop or improve preschool programs
 - Become eligible for stable funding (0.5 ADM) by implementing the EEP Standards
- Eligibility:
 - Districts with children unserved by existing quality preschool programs
- Preference given to:
 - Lower performing districts



• Structure:

- Three-year grant cycle
- Legislative appropriation of \$3 million annually
- Next application period will open spring 2026
- Application will be found at <u>Early Learning Program Funding</u> <u>Options</u>

Eligible districts will count 4- and 5-year-olds enrolled in preschool in their average daily membership count.

Origin: <u>AS 14.17.500(d)</u>

(d) Except as provided in (e) – (g) of this section, a student in a district-wide early education program provided by a school district and approved by the department under <u>AS 14.07.020</u>(a)(8) is counted as one-half of a full-time equivalent student.

Purpose: stable funding for school district preschool programs.



Requirements:

- Operate a program for three or more years
- Consult with Head Start agencies to prevent duplication
 - See <u>Early Learning Program Funding Options</u> for resources regarding Head Start Consultation
- Implement Alaska Early Education Program Standards
 - See <u>Early Learning Alaska Reads Act</u> for resources regarding implementing the EEP Standards
- Employ teacher(s) and paraprofessionals with required certification
 - See <u>Early Education Program Staffing Guidance</u>
 - See <u>AK Reads Early Education Lead Teacher Endorsement</u>



Not eligible: Dist

Districts that receive state and/or federal funding specifically for pre-kindergarten programs.

Structure:

- Applications are submitted by *district-wide* early education programs, not individual schools
- Applications are accepted annually, due May 15
 - See <u>Program Funding Options</u> for the application and resources
- Applicants are notified of approval by September 1
- A successful applicant will start including preschool students in the fall OASIS count of the year it is approved
- Successful applicants will certify annually that their early education program complies with the Early Education Program Standards
- Successful applicants will submit a reapplication every three years





Current 0.5 ADM recipients:

- Anchorage School District
- Skagway School District
- Valdez School District
- The first district was approved for 0.5 ADM funding in the 2023-2024 school year.
- Additional districts are approved through an annual application process.
 - Applications are due by May 15

Helpful Hints to apply for 0.5 ADM

Start Early

- A collaborative consultation with Head Start requires time.
- Some components of the EEP Standards have a time frame.
- *Many* components of the EEP Standards require written policy or procedure; writing and approval take time.
- Some components of the EEP Standards may be associated with staffing reorganization or change.

Utilize a team for:

- Planning
- Analyzing current implementation of the EEP Standards
- Working on the application for 0.5 ADM
