




# Reads Act Programmatic Elements: 1) District Reading Improvement 2) Department Reading Program 3) Pre-K and Parents as Teachers

# Alaska Reads Act: Educator Qualifications

#### **Alaska Reads Act: Educator Qualifications**

- Training, coursework, or testing in phonemic awareness, phonics, vocabulary development, reading fluency, oral language skills, and reading comprehension
- Approved by the state board in regulations





#### **Alaska Reads Act: Educator Qualifications**











#### Proposed Regulations Educator Qualification Tracking

The department will add specific AK Reads endorsements to an educator's certification verifying qualification requirements have been satisfied.

- Reads Act Verified Early Educator Lead
- Reads Act Verified K-3rd Teacher
- Reads Act Verified K-3rd Administrator
- Reads Act Verified Reading Teacher





#### **Proposed Reads Act Verified Early Education Lead Endorsement**

- Two years to complete
- Requirements for the endorsement:
  - Valid teaching certificate
  - Training/Experience:
    - Six credit hours in early childhood education OR
    - Two or more years experience teaching kindergarten or an early education program and successful completion of an evidence-based reading training course approved by the department that includes a summative assessment.





#### Proposed Reads Act Verified K-3 Teachers & Administrators Endorsements

- Phased in over the next two years
- Requirements for the endorsement:
  - Valid teaching certificate
  - Training/Experience:



- Successful completion of a three-semester hour (or equivalent) evidencebased reading training course approved by the department that includes a summative assessment OR
- Evidence of obtaining a passing score on a department approved assessment



#### Proposed Reads Act Verified District Reading Teacher Endorsement

- Two years to complete
- Requirements for the endorsement:
  - Valid teaching certificate
  - Training/Experience:
    - One of the following:



- Successful completion of a three-semester hour (or equivalent) evidence-based reading training course approved by the department that includes a summative assessment <u>OR</u>
- Evidence of obtaining a passing score on a department approved assessment
- Submission of a reading instruction efficiency evaluation form certified by a district representative



#### Proposed Regulations Evidence-based Reading Exams

Achieve the required scores or higher on one of the examinations described in the following tables:

Proposed Regulations Evidencedbased Reading Training Courses

#### Evidence-based reading course or training


- phonemic awareness,
- phonics,
- vocabulary development,
- reading fluency,
- oral language skills, and
- reading comprehension
- ➤Three semester hours or the equivalent
- ➢Includes a summative assessment
- Department of Education & Early Development approved



#### Proposed Regulations Endorsement Application Process

Educators will apply for the Alaska Reads Act endorsements

- Submit with application
  - Transcript, certificate, or test scores
  - District Assurance Form/ Documentation of student growth (Reading Teacher only)
  - \$50.00 fee (Through 2028)


