Crosswalk: Alaska Studies & Alaska History, 1998 to 2024

Purpose and Audience

This document was drafted to:

- Define the terms "Alaska Studies" and "Alaska History" as they apply to the newly adopted (2024) Alaska Social Studies Standards¹
- Compare the 1998 Alaska Social Studies Standards (and the 2006 Alaska History Framework) to the 2024 Alaska Social Studies Standards in terms of Alaska Studies and Alaska History standards, courses, and content

This document is intended to support the following audiences:

- Teachers in Alaska who teach social studies or Alaska History
- Pre-service teachers preparing to teach Social Studies or primary grades in Alaska
- Alaska Districts
- Interested Community Partners

Key Vocabulary

Alaska Studies: may refer to:

- 1. Any Social Studies discipline focused on Alaska content, including Alaska History, Alaska Geography, Alaska Government, and Alaska Native Cultures and Languages.
- 2. Grade 6 course in "Alaska Studies and Geography" as articulated in the 2024 Alaska Social Studies Standards.

Alaska History: may refer to:

- 1. High School course in Alaska History offered to meet the Alaska state high school graduation requirement of one-half unit of credit in Alaska history.
- 2. Grade 3 course on "Alaska's Past, Present, and Future" as articulated in the 2024 Alaska Social Studies Standards.
- 3. Standards related to Alaska History which occur across the grades in the 2024 Alaska Social Studies Standards.

Three Courses

In the 2024 Standards, three courses at three grade levels feature an Alaska content focus.

Context

On December 9, 2024, the Alaska Board of Education adopted the revised Alaska Social Studies Standards. This revision followed a process begun by DEED in February of 2021². The previous (and initial) Alaska Social Studies Standards were adopted in 1998.

Comparison

The 2024 standards feature significant changes in the structure, quantity, and frequency of Alaska Studies and Alaska History content and standards as compared to the 1998 standards.

Alaska Standards and Content Across Grades

Alaska is referenced in multiple anchor standards across the disciplines and grade levels, K-12 (see Figure 3). Differentiated Alaska content appears in the leveled content standards for many anchor standards, at many grade levels, whether or not those standards are part of an Alaska-specific course (see examples in Figures 4-6).

This means a student will encounter Alaska content and Alaska Studies / Alaska History standards spiraled within and without Alaska-specific courses in multiple grade levels K-12.

Origins of the Alaska History Requirement

In 2005, the Alaska Board of Education amended regulation 4AAC 06.075, the Alaska High School Graduation requirements, to include a required half unit of credit in Alaska History.

"Beginning January 1, 2009, the three units of credit in social studies required under (b)(2) of this section must include one-half unit of credit in Alaska history or demonstration that the student meets the Alaska history performance standards."³

As a result of the required Alaska History half unit of credit, many districts offer Alaska History as a required course for high school students, and, in 2006, an Alaska History Framework was added to the existing 1998 Alaska Social Studies Standards.

2006 Alaska History Framework

The 2006 Alaska History Framework organized the Alaska History course into four central themes: People, Places, Environment; Consumption, Production, Distribution; Individual Citizenship, Governance, Power; Continuity and Change.

The framework divided Alaska History into five chronological periods with suggested topics. Each chronological period featured multiple content standards for each theme. See Tables 1 and 2 for lists of themes, chronological periods, and topics from the 2006 Alaska History Framework.

Alaska History in the 2024 Standards

In the 2024 Alaska Social Studies Standards, the high school Alaska History course content standards are organized into six themes and four disciplines, with Inquiry Standards embedded throughout (see Figure 7).

The 2024 course includes five time periods and timeframes, a very similar structure to the 2006 Alaska History Framework (see Figure 8).

Summary of Key Takeaways

Definitions:

- "Alaska Studies" refers to any discipline focused on Alaska content, as well as the Grade 6 course articulated in the 2024 Alaska Social Studies Standards.
- "Alaska History" refers to the required, half-credit HS course, and may refer to the Grade 3 course articulated in the 2024 standards, and any standards related to Alaska History.

Key differences between 1998 and 2024 Alaska Studies / Alaska History standards:

- 3 Alaska-focused courses are articulated in the 2024 standards:
 - Grade 3: Alaska's Past, Present & Future
 - Grade 5: Alaska Studies & Geography
 - Grade 9-12: Alaska History (required for graduation)
- Alaska content and Alaska-related standards appear throughout the grade levels and content standards; as a result, students will encounter Alaska content and standards throughout K-12
- 2024 AK History Course vs 2006 AK History Course
 - Similarities: time frames, time periods
 - Differences: 2024 organized by 6 themes, with 4 disciplines, and Inquiry Standards embedded throughout
