

Request for Flexibility for FY19: Consolidation of Title I-C Funds into a Title I-A Schoolwide Program

The Guidance for the Consolidation of Title I-C Funds into the Schoolwide Program, approved by the Office of Migrant Education on April 1, 2014 states:
