

FY 2026 COMMISSION ACTIONS

At the **October 6-7, 2025**, Professional Teaching Practices Commission Meeting the Commission took the following action:

PTPC Case 24-03: The Commission imposes the **revocation for life** of the Professional Teaching Certification of **Nathaniel E. Erfurth**.

PTPC Case 24-35: The Commission ordered the **reprimand** of **April D. Hoy's** Professional Teaching and Administrative Certificates.

PTPC Case 25-04: The Commission ordered the **one-year suspension** of the Professional Teaching Certification of **Sandra Graves**, effective July 10, 2024.

PTPC Case #25-09: The Commission ordered the **one-year suspension** of the expired Initial Teaching Certificate of **Marian D. Ritter**, effective September 4, 2024.

PTPC Case 25-13: The Commission ordered the **one-year suspension** of the Professional Teaching Certification of **Michelle Lickfield**, effective September 26, 2024.

PTPC Case 25-20: The Commission rejected a stipulated agreement for a sanction against the Teaching Certificate of an educator and dismissed this case.

PTPC Case #25-22: The Commission ordered the **one-year suspension** of the Initial Teaching Certification of **Julie J. Cowles**, effective December 26, 2024.

PTPC Case #25-23: The Commission ordered the **one-year suspension** of the Provisional Special Services Certification of **Michael A. Kusmitch**, effective December 21, 2024.

PTPC Case #25-24: The Commission ordered the **one-year suspension** of the Initial Teaching Certification of **Nikolas V. McGraw**, effective November 26, 2024.

PTPC Case #25-28: The Commission ordered the **one-year suspension** of the Emergency Teaching Certification of **Devin E. Lawrence**, effective January 7, 2025.

At the **January 29, 2026**, Professional Teaching Practices Commission Meeting the Commission took the following action:

PTPC Case #24-45 In the matter of PTPC Case 24-45, I move that the Commission accepts the Mediated Settlement of a warning with conditions of the Professional Teaching certificate of an educator.
