(f) If a school is required to offer supplemental educational services under 4 AAC 06.840, a **clear and concise** notice under (e) of this section also must explain how parents can obtain supplemental educational services for the student. **The notice must** [, INCLUDING]

(1) **include** the identity of approved providers of those services available within the district, including providers of technology-based or distance-learning supplemental educational services, and providers that make services reasonably available in neighboring districts; [AND]

(2) **include** a brief description of the services, qualifications, and demonstrated effectiveness of the providers; **and**

(3) be clearly distinguishable from the other information sent to parents under this section.
