## Data Collection – School Operating Status

- › DEED will gather data from districts at the school level that indicates whether each of the following **modes of instruction** were **offered** to students **as of March 29<sup>th</sup>, 2021**:
  - Remote or online only
  - School buildings open with both remote/online and in-person instruction (hybrid)
  - School buildings open with full-time in-person instruction



# Data Collection – School Operating Status – Offered

- › For each school, districts will be asked to report whether the mode of instruction was offered to all students, some students, or not offered **as of March 29<sup>th</sup>, 2021:**

## Data Collection – School Operating Status – Primary

- › To calculate students enrolled, DEED will gather data from districts at the school level that indicates which of the following modes of instructions was primary (majority of students were instructed under this type) as of March 29<sup>th</sup>, 2021:

222222	Hybrid
333333	In-Person
444444	Remote or Online Only
555555	Hybrid





# Data Collection – School Operating Status – Forecasted Instructional Type for Fall 2021-2022

- › DEED will gather data from districts at the school level that indicates **which** of the following **modes of instruction** is planned to be **primary** (majority of students will be instructed under this type) for Summer 2021 and the 2021-2022 school year:

## Data Collection – School Operating Status

- › The data collection tool will be distributed to superintendents and data collection/submission contacts in each district by no later than end of the day today.
- › Responses are due back by May 17th.
- › After the data collection is complete, data will be compiled and included in the state plan.
- › DEED is also required to publicly post this data on the website no later than 14 days after the submission of the plan (June 21<sup>st</sup>).



# Data Collection in the Future



## Student Level Data

- › Access to Technology (Fall OASIS 2021)
- › Student learning, including the academic impact of lost instructional time during the COVID-19 pandemic (Assessments/Participation Rate 2021/2022)
- › Student Engagement (Summer OASIS 2022)
- › Access to and Participation in Advanced Coursework (Summer OASIS 2022)
- › Participation in programs funded by ARP ESSER resources (e.g., summer and afterschool programs) (Summer OASIS 2022)
- › Results from Student, Parent, and/or Educator Surveys



## School Level Data

- › Educator Access to Professional Development on the Effective Use of Technology (Report Card 2021)
- › Data on each school's mode of instruction (fully in-person, hybrid, and fully remote) and conditions (Report Card 2021)
- › Jobs Created and Retained (by position type) (new data collection)
- › Results from Student, Parent, and/or Educator Surveys

- › Access to High-Quality Educators (Certified and Classified Staffing 2021)
  - › Access to School Counselors, Social Workers, Nurses, and School Psychologists (Certified and Classified Staffing 2021)
  - › Per-Pupil Expenditures at the LEA and School Levels (Report Card 2021)
