


## **FY23 Condensed Application**

- > The Condensed Application is for all designated schools in our state except Kalskag, Nightmute, Tetlin, Selawik, and Wales.
  - These five schools are piloting a new process for school improvement.
- > After the five Cohort 1 schools provide feedback on the new process, it will be rolled out next school year.
- > Non-cohort 1 schools are being provided a respite this spring in the expectation for the 2022-23 S.Y. they will engage in the more extended and involved school improvement process that results in the development of a three-year plan.



## **Condensed Application Components**





### Evidence-Based Requirement

- > The intervention found in your plan must be backed by at least one study showing positive and statistically significant effects on student outcomes or other related outcomes
  - Prioritize strong evidence or moderate evidence describing the effectiveness of an intervention through causal inference
  - <u>US DOE Non-Regulatory Guidance: Using Evidence to Strengthen</u> <u>Education Investments</u>



### Evidence-Based Repository of Research

#### > What Works Clearinghouse

- > Consider population, setting, context, and resources
- Make sure study impacts student outcomes or other related outcomes
  - student engagement/achievement, course completion/graduation rate
  - teacher development and retention
  - community and diverse stakeholder involvement
  - school climate for learning

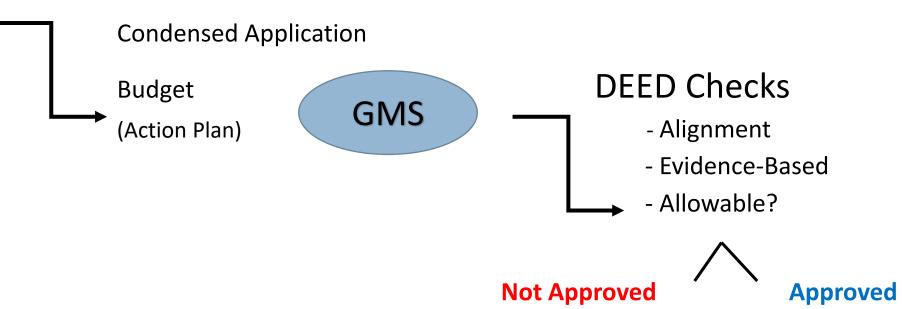

### Reasons for Non-Approval Recorded in GMS

#### > If your 1003(a) grant is returned

- DEED Program Manager Not Approved
- DEED Administrator Not Approved
- > See the Grantee Checklist in GMS
  - Specific reasons will be checked off
  - Supporting evidence will be cited
  - Contact School Improvement Program Manager if you have any questions

#### > Edit to meet requested changes

- Fiscal Representative will need to approve after new changes are added



### **Budget Narrative Guidelines**

- > Clearly tie expenditures to Needs, Goals, and Plan
  - Include Purpose
- > New resource providing requirements and exemplars
  - > Budget Narrative Guidelines for 1003(a) Grants



### Allowable Expenses

- > Allowable Cost Checklist
- > Necessary
- > Reasonable
- > Conforming to Federal Statutes
  - Limitations/Exclusions Unallowable Costs/Expenses
- > Aligned with Needs
- > Evidence-Based



### Supplant vs Supplement

- District initiatives cannot be funded wholly with school improvement grant funds
- > Nor can a district initiative be funded at the district level for all schools except the designated schools
  - It would be inappropriate to expect designated schools to pay for something that is being paid by the district for non-designated schools
