

- 5. Improve the safety and well-being of students through school partnerships with families, communities, and tribes.







What are cut scores?

- Cut scores are those scale scores that sit at the borders of two achievement levels and allow us to define proficient and non-proficient performance.
- Cut scores separate test takers into various categories.
- In Alaska, three cut scores classify students into four achievement levels.



Why conduct a standard setting validation?

- We are now further removed from the impacts of the COVID-19 pandemic and its influence on schools throughout the state.
- In 2023, the AK STAR test design and administration model was shifted by design and with intention.
- We have another year's worth of test data to review and evaluate.

Outcomes of the Standard Setting Validation

- Ratings and discussion of the cut points between the performance levels
 - ✓ Provided information about where 2022 cut scores were set
 - ✓ Identified error bands around the 2022 cut scores
 - ✓ Two rounds of independent ratings
 - ✓ Vertical articulation
- Moving a cut score recommendation within one or two CSEM values is generally viewed as maintaining consistency with the cut score recommendations.
 - The results of the 2023 standards validation largely showed that the recommended cut scores were not different from the 2022 cut scores (ELA, mathematics, science).



Support for the Validation Study

✓ The Technical Advisory Committee and Center for Assessment commended DEED for their careful and thorough review of Alaska's assessment achievement standards, and concern for the quality, comparability, and utility of the scores.



Science Reporting



- DEED leadership determined that the outcome of the validation study provides support that the standards set in 2022 for the Alaska Science Assessment were validated and should not be changed.
- DEED will move forward with the performance standards for the Alaska Science Assessment, established in 2022, maintaining the cut scores for all grades and achievement levels as shown on the slide, as adopted by reference in AAC 06.739, <u>Assessment achievement level scores</u>.

Policy Review Meeting



- DEED engaged a Policy Review Committee to further review the process, outcomes, and policy considerations related to establishing the AK STAR achievement level scores.
- Policy Committee members include representatives from the standard setting and validation study educator panels, district leaders, policymakers, and representatives from higher education, business community, and a parent organization.



Policy Review Meeting – Outcomes

- The Policy Review Committee determined that changes to the AK STAR achievement level scale score ranges established in 2022 are warranted.
- Adjusted cut scores are being presented to the State Board of Education for consideration.


