# K-12 Foundation Program and Pupil Transportation

- K-12 Foundation program is fully funded based on the statutory formula; Total: \$1,145,790.2 UGF and Public-School Trust Funds.
- Pupil Transportation is fully funded based on statutory formula; Total: \$70,594.5 UGF. An additional \$7,305.9 UGF to be distributed to districts according to the Pupil Transportation Formula.
- Additional Foundation Funding to ensure minimum funding equivalent to \$680 BSA increase. \$174,663.5 UGF

# School Debt Reimbursement & Regional Educational Attendance Area (REAA) and Small Municipal School District School Fund

- Both programs are fully funded based on the statutory calculation:
  - School Debt Reimbursement to municipalities for selected bonds issued for school construction; Total: \$57,517.7 UGF and DGF.
  - o REAA Fund for school construction projects; Total: \$26,978.0 UGF.

## **Finance and Support Services**

- Authority for Program Coordinator II was added to support School Broadband Assistance Grants Program; Total \$116.6 Interagency Receipts (Other).
- School Broadband Assistance Grants was transferred from the Division of Libraries, Archives and Museums to Education Support and Administrative Services.

### **Innovation and Education Excellence**

- Statewide assessment support; Total \$650.0 UGF.
- Alaska Resource Education (ARE) Grant for Statewide Workforce Development Initiative for FY2024-FY2025; Total: \$500.0 UGF.
- Alaska Native Science and Engineering Program Partnership grant; Total: \$5,000.0 UGF.
- Grant Funding for Hunter Education was decreased by half with a new total of \$500.0 UGF.
- Career and Technical Education (CTE) Program was transferred to a new CTE Component for program alignment.
- Alaska Teacher's Recruitment, Retention, Certification, and Apprenticeship Development; Total: \$1,500.0 UGF.
- Replace unavailable federal COVID relief authority for Statewide Coding and Computer Science Career Coordinator; Total: \$146.8 UGF.
- Continue Coding in Minecraft Program for school districts to meet Computer Science Education Initiative was decreased by half with a new total of \$600.0 UGF.
- CTE Initiative funding was continued but decreased by half with a new Total of \$750.0 UGF.
- The Statewide Coding and Computer Science Career Coordinator position was transferred from Non-Perm to Full-Time.
- Added the Alaska Reads Act Advisory panel; Total \$75.0 UGF

  - o Nelson Island School Replacement, Toksook Bay Phase 1 \$21,614,500
- Major Maintenance Grant Funds FY24 Supplemental Total \$36,190,793.00 and FY25 Total \$26,570,936.00 funding projects on the January 12, 2024, FY2025 Major Maintenance Grant Fund priority list the first 26 projects is fully funded with this total.
