CHILD NUTRITION PROGRAM STATE WAIVER REQUEST TEMPLATE

Child Nutrition Programs are expected to be administered according to all statutory and regulatory requirements; waivers to the requirements are exceptions. However, Section 12(I) of the Richard B. Russell National School Lunch Act, 42 U.S.C. 1760(I), provides authority for USDA to waive requirements for State agencies or eligible service providers under certain circumstances. When requesting the waiver of statutory or regulatory requirements for the Child Nutrition Programs (CNPs), including the Child and Adult Care Food Program (CACFP), the Summer Food Service Program (SFSP), the National School Lunch Program (NSLP), the Fresh Fruit and Vegetable Program (FFVP), the Special Milk Program (SMP), and the School Breakfast Program (SBP), State agencies and eligible service providers should use this template. State agencies and eligible service providers and eligible service providers and eligible service providers at least 60 calendar days prior to the anticipated implementation date. Requests submitted less than 60 calendar days prior to the anticipated implementation should be accompanied by an explanation of extenuating circumstances.

4. Description of the challenge the State agency is seeking to solve, the goal of the waiver to improve services under the Program, and the expected outcomes if the waiver is granted. [Section 12(I)(2)(A)(iii) and 12(I)(2)(A)(iv) of the NSLA]:

Alaska DEED seeks to prepare for the potential that a school, summer food distribution site, or at-risk afterschool care center could close for any number of reasons to include natural disaster, fire, strike, equipment failure or repair, public health emergency, court order, closure due to food or environmental safety, act or threats of terrorism, structural damage, or any other reason that would cause an unexpected closure of the school and/or food service facilities or infrastructure.

- For the Summer Food Service Program and Seamless Summer Options
 - Non-Congregate Meal Service during Unanticipated School Closures [42

6. Detailed description of alternative procedures and anticipated impact on Program operations, including technology, State systems, and monitoring:

In the event of an unanticipated closure, the impacted sponsor shall contact Alaska DEED requesting to exercise some or all options of this waiver for a period of ten or fewer days. Alaska DEED will approve sponsors on a case-by-case basis and will provide guidance and technical assistance as each specific situation warrants. Alaska DEED and the sponsor will regularly communicate to determine if the expected duration of the closure will exceed ten days. If the duration is expected to exceed ten days, Alaska DEED will seek an appropriate waiver for the specific sponsor and site for the extended period of time.

7. Description of any steps the State has taken to address regulatory barriers at the State level. [Section 12(I)(2)(A)(ii) of the NSLA]:

No regulatory burdens exist at the State-level.

8. Anticipated challenges State or eligible service providers may face with the waiver implementation:

This waiver reduces challenges created by unexpected closures by giving the State and sponsor flexibility to address the situation.

9. Description of how the waiver will not increase the overall cost of the Program to the Federal Government. If there are anticipated increases, confirm that the costs will be paid from non-Federal funds. [Section 12(I)(1)(A)(iii) of the NSLA]:

Alaska CNP does not anticipate this waiver will increase the overall cost of the program to the Federal Government.

10. Anticipated waiver implementation date and time period:

For the National School Lunch and School Breakfast programs, this waver is to be effective immediately upon approval and shall remain in force until 30 June 2024 For the Child and Adult Care Food Program, this waiver is to be effective immediately upon approval and shall remain in force until 30 June 2024

For the Summer Food Service Program and the Seamless Summer Option, this waver is to be effective immediately upon approval and shall remain in force until 30 April 2024

11. Proposed monitoring and review procedures:

Alaska DEED will require sponsors to request approval to utilize this waiver and provide oversight, technical assistance, and request an extension from FNS WRO on as-needed basis.

12. Proposed reporting requirements (include type of data and due date(s) to FNS):

Alaska DEED will report the date, location, program(s), and reasons for utilization of this waiver by 30 September 2024.

- Congregate meal service
- Meal Service Times
- Parent/Guardian Meal Pick up
- Service of Meals at School Sites

During unanticipated school closures for CACFP at-risk after school centers DEED would like to waive:

- Congregate meal service
- Meal Service Times
- Parent/Guardian Meal Pick up
- Enrichment Activity

These program flexibilities will help ensure students continue to receive healthy meals during natural disasters and reduce administrative burdens on sponsors as they deal with recovery efforts. DEED will provide technical assistance to sponsors to ensure successful implementation of the waiver. DEED requests to implement this waiver immediately upon approval through June 30, 2024, for NSLP and CACFP and through April 30, 2024, for SFSP.
